However, Members who are already enrolled in a 30-day home health episode of care as of **2/1/2025** may continue receiving those services through the end of the certification period. At that point, a re-authorization request must be made to tango for continued services. Out-of-network agencies will be offered the opportunity to take steps to join the network or will be required to transition the member to an in-network provider at the end of the certification period. For all new start of care home services starting on or after **2/1/2025**, must be directed to tango.
